

The Orchid Mart is our largest fundraising event of the year. Your presence and contributions are greatly appreciated.

We will be having a Show & Tell plant table like we do at our general meetings. If you have something to show others, please bring it so others can see what you are blooming.

Other than the Show & Tell table, all plants brought to the sale are considered donations to GLOS. Please make sure your plants are pest-free.

- 1. Each table, or section, will be allocated for specific prices as indicated by the color of the labels, i.e.:
 - \$2 vellow
 - \$5 pink
 - \$10 green
 - \$15 blue
 - \$20 red
 - \$25 white

Live Auction table: There will be a separate table for the live auction of a few selected plants.

- 2. Please predetermine the prices for the plants (etc.) you bring for sale, and let the volunteer who greets you know so he/she can give you the appropriate price labels for your plants. If you have your plants all priced before you arrive, it will go more smoothly. Also remember that if you bring something to sell, make sure you take it home if it is unsold (or make arrangements with someone else to do that). Otherwise, it will likely be thrown away.
- 3. Bring your plants (etc.) between 9 and 9:30 so sales can begin promptly at 10:00.

PRESIDENT'S MESSAGE -- Pete Ostlund

I hope you're enjoying the warmer temps of summer. If you put your orchids outside, they are probably enjoying it too. As I write this, temps are in the 90s and it's very humid. I purchased some Disas last fall, something new for me to try to grow. It's fairly difficult to find sources of these in the U.S., but I managed to snag 3 of them. Unlike most of my other orchids, they don't like summer heat. So rather than put them outside (or keep them in the greenhouse), I took them inside the house for a while to avoid the heat. One looks like it's about the bloom, so perhaps I'm doing something right (or it's getting ready for its death bloom, one last attempt to propagate before it kicks the bucket). I learn more about orchids when I purchase something new and attempt to get it to live, thrive and flower (I'm more likely to research the cultural needs if I have a vested interest in it).

Our picnic is coming up Saturday, July 23. It should be a good time, as usual. There are always plenty of plants to grab for a very cheap investment. I hope you'll be able to make it this year. There's more information about the picnic elsewhere in the Calypso. We're at a new location this year, not too far from last year's site. Perhaps you'll venture to buy something new to test or enhance your orchid prowess.

Our August meeting (August 13) will be a zoom meeting about native orchids. Doug Martin is our speaker. Our September meeting is an in-person meeting (Sept 17). Edgar Stehli of Windswept in Time Orchids will be with us and have plants to sell. I hope you'll be able to make all of these events.

DONATING ORCHIDS TO OUR PICNIC SALE:

Please keep in mind, however, that shared plants should be healthy, free of diseases and insects, and be generally well-cared for. Just as you wouldn't want to take home a sick plant, neither should you expect others to accept one. Such plants are better off becoming a part of a compost pile than potentially passing on their ailment(s) to another's collection.

The Society does have a responsibility to not allow diseased or insect-infested plants to be distributed at our meetings.

However, we all take great pleasure in finding, growing and blooming treasures from fellow orchid lovers.

CULTURAL NOTE

Water, Water, Everywhere

Watering seems to be a pretty basic subject, because we all recognize that plants need water. However, what I want to stress - yet again - is that your watering regimen is the single, most-important aspect of orchid culture. I know that sounds odd, coming from a guy who peddles biostimulants, fertilizer and probiotics, but without proper watering, they cannot fully come into play. Let's look at some details.

Readily-available water at the roots triggers plant activity for growth - literally. If the external water supply is plentiful, the roots send a hormonal signal up through the vascular system that tells the plant to open its stomata. It is through those stomata that the plant is able to take in carbon dioxide, enabling carbon fixation and growth. Additionally, when those pores are open, water can be lost through them, and it is that imbalance that causes the transpirational "pull" necessary for water, collected by the roots, to be pulled upwards throughout the plant.

That regular flow of water serves several additional purposes, as water is an ingredient in the sugar produced through photosynthesis that fuels plant activity, is part of carbohydrates, enzymes, fatty acids and pretty much everything else that makes up the chemistry of plants, and provides the turgidity - internal water pressure - needed to keep the plant upright and to open and fill out flowers.

You've probably heard/read that in order to add one pound of mass, a plant must incorporate about 200 pounds - about 25 gallons - of water, but only about a teaspoon of NPK fertilizer. What may be even more astounding is that the 25 gallons of water constitutes only 3%-5% of the water absorbed by the plant, with the balance lost trough transpiration. That's right - in order for a plant to gain a pound, it must absorb as much as 1000 gallons of water. That's four tons!

Experienced orchid growers know that we must prevent suffocation of the plants' root systems. How that is accomplished can be controlled by the proper choice of container and potting medium that works well with the individual's growing conditions and his or her watering preferences or capabilities. That being said, for the benefit of the plant, it is far better to use a very "open" medium and water frequently, than it is to use a denser medium that requires substantial drying before being watered again.

In that second scenario, dry roots, no matter how short of a period, tells the plant to "take a break " rather than supporting continued growth, in effect stalling the plant's growing efforts.

Centre to Drew Goddard's lecture on the various, new Phalaenopsis species. Norman Fang, owner of Norman's Orchids in California, spoke on "New color forms of Phalaenopsis species".

Because there was no opportunity for any sort of live auction to raise money to offset the expense of the webinar, the Great Lakes judges are offering a set of beautiful note cards featuring award photos submitted by the four photographers from the Center: Lynn O'Shaughnessy, Katie Payeur, Ed Cott, and Mei Ling Clemens. 


